#### Call for Nominations for the Annual SPA Awards

Deadline for submitting: February 28, 2012

Any individual SPA member, or SPA Chapter as a whole, may submit nominations in writing to the Awards Chairman of an <u>SPA MEMBER</u>, of any chapter, or an SPA member who is unaffiliated with any chapter, who is deemed worthy of an SPA award in the categories listed below:

### LIFE TIME ACHIEVEMENT AWARD:

The Life Time Achievement Award is a special award that is given during the dinner banquet at the SPA annual meeting. A nominee should have at least 25 years of outstanding service to archaeology in Pennsylvania and/or SPA, should have been a member of SPA for the same amount of time, and be an exemplary proponent of the purpose and objectives of SPA. Recipients can be professional archaeologists (or professionals in a closely related science), or avocational archaeologists who exhibit an outstanding record of contributions to the field of archaeology and to the SPA. The nominee must demonstrate a passionate dedication to archaeology in Pennsylvania and to the SPA, and work assiduously to promote archaeology and/or historic preservation in the Commonwealth through public outreach activities. The nominee should have inspired others to become involved in the SPA and in Pennsylvania archaeology, or serve as a mentor for students interested in a career in archaeology or a related field.

#### **ARCHEY Award:**

Nominee must be a member of SPA, not just a chapter. This award is presented to a non-professional who has given significant contributions, over an appreciable period of time, toward the unselfish furtherance of archaeology. The number of separate nominations and the significance of the reasons for the nomination are weighed in making the selection for this award.

The individual's contributions toward archaeology may be offices held; numbers and kinds of speaking engagements; published articles or reports; number and kinds of sites recorded and/or excavated; work with young people to acquaint them with archaeology, etc.

**J. ALDEN MASON Award**: This award is presented to an SPA member who is a professional archaeologist and is based on his or her contribution to education and encouragement of SPA members in the proper pursuit of archaeology. A professional in a related science, which similarly assists SPA members, may also be considered for this award. The nominee need not reside in Pennsylvania.

**JOHN WITTHOFT Award:** This award is presented to the chapter of the SPA that recruited the most new SPA members or reinstated the highest number of delinquent SPA members since the previous SPA Annual Meeting.

**SHRADER/GEORGE Award**: Nominee must be an SPA member under 18 years of age and be an example of the SPA's ideal youth, whose character, accomplishments, and unselfish effort have furthered the cause of Pennsylvania archaeology.

Sites upon which the nominee has participated should be recorded and have a designated State site number and the nominee should have experience in recording such sites and properly cataloging artifacts from the sites.

Please provide adequate background and information on nominees as inadequate information or failure to meet the award criteria could result in disqualification.

**FRANCES DORRANCE AWARD:** This is an award that will be given to the Chapter of the SPA that has recorded the most new sites with the Pennsylvania Archaeology Site Survey at the State Museum, Harrisburg, PA, **FOR THE CALENDAR YEAR OF 2010.**

We anticipate that at least three such scholarships of \$100 apiece will be awarded. We encourage all current students in Pennsylvania high schools or universities with an interest in archaeology and the activities of the SPA to apply, although preference will be given to students planning to present papers at the meeting. #### W. Fred Kinsey Scholarship

The annual W. Fred Kinsey Meeting Scholarship will provide student membership to The Society for Pennsylvania Archaeology for one year, a \$100.00 award, and banquet costs for the annual meeting. Dr. Kinsey was a curator with the PHMC before going to Franklin and Marshall College and The North Museum from the early 60's thru the mid 1980's. His work on the prehistory of the Upper Delaware laid the foundation for much of the interpretation of this region of Pennsylvania. In addition to his contributions to archaeological investigations he mentored many students who went on to become significant archaeologists on their own merits.

Students currently pursuing an undergraduate or graduate degree are eligible to apply for the W. Fred Kinsey Meeting Scholarship. Eligibility is dependent on a complete, single-author paper with PowerPoint slides (if appropriate) to be presented at the annual meeting of The Society for Pennsylvania Archaeology. To be eligible for the award the student presentation must have been accepted by the program chair for the SPA annual meeting. Papers should focus on topics relevant to Pennsylvania archaeology. Award of the Scholarship requires submission of the complete paper by a single author, in an electronic format (Word or WordPerfect) to the Program Chair by the regular submission deadline date for papers as set by the Program Chair. The Program Chair Persons this year are Amanda Valko and Brian Fritz <a href="AVALKO@mbakercorp.com">AVALKO@mbakercorp.com</a>, deadline for submission is March 23, 2012. Selection of the winning paper will be based on quality of original research, presentation and appeal to the avocational and professional archaeology community. The committee consists of at least three members of the Society, one from staff of the PHMC and one member from the education committee of the Society. Students are eligible for both the Hatch Scholarship and the Kinsey Meeting Scholarship. Two scholarships are available from the Kinsey fund this year, one each at the undergraduate and graduate level.

Presentation of the award will be announced at the Annual Meeting of the Society for Pennsylvania Archaeology in April. The selected paper will be published on-line through the PHMC website and submitted for review to the editor of the journal *Pennsylvania Archaeologist* for possible publication. The editor of the journal will make the final decision on publication.

## National Park Service's 2012 Archaeological Prospection Workshop

The National Park Service's 2012 workshop on archaeological prospection techniques entitled *Current Archaeological Prospection Advances for Non-Destructive Investigations in the 21*st Century will be held May 7-11, 2012, at the Cedar Point Biological Station near Ogallala, Nebraska. Lodging will be at the Cedar Point Biological Station near Ogallala, Nebraska. The field exercises will take place at the site of Alkali Station near Paxton, Nebraska. Alkali Station was a major trail facility used by travelers on the Oregon and California trails, the Pony Express, the transcontinental telegraph, and the frontier army. Co-sponsors for the workshop include the National Park Service's Midwest Archeological Center, the Lute Family, and the University of Nebraska's Cedar Point Biological Station. This will be the twenty-second year of the workshop dedicated to the use of geophysical, aerial photography, and other remote sensing methods as they apply to the identification, evaluation, conservation, and protection of archaeological resources across this Nation. The workshop will present lectures on the theory of operation, methodology, processing, and interpretation with on-hands use of the equipment in the field. There is a registration charge of \$475.00. Reconstruction of fort built by William Henry Harrison on the Maumee River in 1813 to protect northwest Ohio and Indiana from British invasion. The 3,000 square foot museum contains exhibits and artifacts relating to the War of 1812.

#### Workshops in Archaeology at The State Museum of Pennsylvania, November 5th, 2011

We are delighted to report on the success of the return of our Workshops in Archaeology program. We hosted just over a hundred people from all avenues who just wanted to learn more about archaeology. Members of the Society for Pennsylvania Archaeology, Pennsylvania Heritage Society members, students, and the general public turned out to learn more about the Prehistory of Pennsylvania. We received support for this program from Navarro and Wright Engineering, TEC inc., URS, and the Pennsylvania Archaeological Council. Workshop participants selected four sessions from a total of eight presentations. Presenters provided participants with an overview of recent research on the major time periods in Pennsylvania from Paleoindian period through the Contact period.

Steve Nissly provided an excellent demonstration on flint knapping that was very popular. Numerous individuals brought in their artifact collections for identification by Doug McLearen and Steve Warfel. This was an excellent opportunity for the avocational community to share their site information and associated collections with Noel Strattan and Tom Held from the Bureau for Historic Preservation. Noel and Tom assisted participants in recording site information in the Pennsylvania Archaeological Site Survey and the Cultural Resources Geographic Information System (CRGIS). Rounding out the offerings was Dr. Bernard Means, who demonstrated three-dimensional scanning of artifacts from both the collections at The State Museum and from the Consol Site (36Wm100).

The closing comments delivered by Dr. Dean Snow, Professor of Anthropology, Penn State University were an opportunity for reflection on our understanding of past cultural behavior and the direction for archaeological research in the future. Presenters and participants enjoyed an opportunity at the end of the day to engage in discussions in an informal reception held in the Hall of Anthropology and Archaeology. Plans are already underway for next year's program scheduled for November 3<sup>rd</sup>, 2012.
